DIRECTOR' S REPORT

EMERGENCY HVAC INSTALLATION- Inter-County Mechanical Corp. installed the HVAC units on December 16 and they are operational. There were some issues addressed with the ignitor on Unit 1. We are pending the delivery of a communication board that will allow the units to be controlled online by the Building Management System (BMS).

BUILDING & GROUNDS- Nickerson installed the back panels on the storage units in the Information Center. We currently have a roof leak that is affecting the Teen Area. On January 10 the library will have a delayed opening due to building repairs; Eveready Roofing and Schumacher Plumbing will be fixing the drain and sealing that area of the roof. There are also asphalt and drain repairs that need to be done in the back parking lot and upper lot.

JERICO SCHOOL DISTRICT- Ms. Cinquemani attended the Jericho School District Wellness Coalition meeting. A representative from the Nassau County Police Department detailed their program offerings to students, Jericho student Elaine Zhang presented the summer debate program that she runs for other students, and the coalition also discussed Narcan training. These meetings are always very informative.

NASSAU LIBRARY SYSTEM- A copy of the draft letter from NLS addressed to the Nassau County Civil Service Commission formally requesting to waive the residency requirement for Librarian, Assistant Director, and Director titles was given to the Board for review. Nassau County is currently the only county in New York State that requires this. Citing difficulties in hiring staff, and the impact on library services and current staff

members, Ms. Cinquemani recommended to the Board that the Jericho Public Library sign this letter along with NLS and other Nassau libraries.

The library will be promoting the Nassau Library Quest from January 25 – March 3. For those familiar with the full Nassau Library Tours that happened in the summers of 2019 and 2023, this is a smaller version of the Tour. Library cardholders, regardless of age, are invited on the Quest. Participants will only have to travel to 10 participating Nassau Libraries to complete the Quest. Gameplay: participants will look for a stuffed Quest cat at each library they visit. The library will then mark their visit on their Quest map. When participants reach their 10th and final library, they will receive a prize and an entry into a grand prize raffle drawing. More information to be posted on the library website.
